Students will not be admitted to the program without the total fee paid under any circumstances. A late payment fee of \$375 will be assigned after 30 days.

The school has the right, in its sole discretion, to dismiss from the school any student if the continued attendance of such student is deemed by the school not to be in the best interest of either the student or the school.

This contract may not be cancelled, nor may any deduction be made from the amount of total fees payable hereunder, because of withdrawal, absence, or any other reason unless written notice of withdrawal and cancellation is received by the school on or before April 18th, 2017, in which event, except for the non-refundable deposit, all payments of the fees herein shall be waived or refunded, as the case may be. In the event that a student is withdrawn for any reason whatsoever after the above date, I / we agree to pay the School as follows:

- (a) If the student withdraws before the opening day, 75% of the total agreed fee for such student for the program.
- (b) If the student withdraws after the opening day, 100% of the total agreed fee for such student for the program.
