In the event that a student is withdrawn for any reason whatsoever after the above date, I / we agree to pay the School as follows:

- (a) If the student withdraws before the opening day, 75% of the total agreed fee for such student for the program.
- (b) If the student withdraws after the opening day, 100% of the total agreed fee for such student for the program.
